State Pharmacy Board Rules

- Applying for CSR to then apply as a DEA Registrant.
 - The cost to obtain a registration is \$100 for agency. The biannual cost to renew the registration is \$60.
 - Individual Paramedics/Adv. EMT requirement of registration are waived under <u>856 IAC 2-</u> <u>3-5-Sec 5,c6d</u>
 - <u>856 IAC 2-1-1</u>


